<b>What is the overall <a href="#">deductible</a>?</b>	For CSN <a href="#">in-network providers</a> : \$500/individual or \$1,000/family For <a href="#">in-network providers</a> : \$1,500/individual or \$3,000/family <a href="#">Deductible</a> per individual applies when the employee is the only individual covered under the <a href="#">plan</a> . If you have other family members on the policy, the overall family <a href="#">deductible</a> must be met before the <a href="#">plan</a> begins to pay.
<b>Are there services covered before you meet your <a href="#">deductible</a>?</b>	Yes.
